## SECTION 4: FIRST AID MEASURES

### Description of First Aid Measures

- Inhalation:** Move exposed person to fresh air. Get medical attention immediately. Treatment is symptomatic for primary irritation or bronchospasm. If breathing is labored, oxygen should be administered by qualified personnel.
- Ingestion:** Do not induce vomiting unless directed to do so by medical personnel. Never give anything by mouth to an unconscious person. Provided the patient is conscious, wash out mouth with water. Get medical attention if symptoms appear.
- Eye Contact:** Immediately flush eyes with plenty of water for at least 15 minutes. Get medical attention immediately.
- Skin Contact:** After contact with skin, wash immediately with plenty of warm, soapy water. Remove contaminated clothing and shoes. Continue to rinse for at least 10 minutes. A poly-glycol based skin cleanser or corn oil may be more effective than soap and water. Get medical attention if symptoms occur. Wash clothing before reuse. Clean shoes thoroughly before reuse.

## SECTION 5: FIRE FIGHTING MEASURES

### Extinguishing Media:

Note: Water may be used if no other available media is available AND used in copious quantities. Reaction between water and hot material may be vigorous. Prevent washings from entering water courses, keep fire exposed containers cool by spraying with water.

### Caution:

Due to reaction with water producing CO<sub>2</sub> gas, a hazardous build-up of pressure could result if contaminated containers are re-sealed. Containers may burst if overheated.

### Hazardous Decomposition Products:

## SECTION 6: ACCIDENTAL RELEASE MEASURES

No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. Do not touch or walk-through spilled material. Do not breathe vapor or mist. Provide adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Put on appropriate personal protective equipment (see Section 8).

Avoid dispersal of spilled material and runoff and contact with soil, waterways, drains and sewers. Inform the relevant authorities if the product has caused environmental pollution (sewers, waterways, soil, or air).

Stop leak if without risk. Move containers from spill area. Approach release from upwind. Prevent entry into sewers, water courses, basements, or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. Contain and collect spillage with non-combustible, absorbent material e.g., sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). Dispose of via a licensed waste disposal contractor. Contaminated absorbent material may pose the same hazard as the spilled product.

## SECTION 7: HANDLING AND STORAGE

Put on appropriate personal protective equipment (see Section 8). Eating, drinking, and smoking should be prohibited in areas where material is handled, stored, and processed. Workers should wash hands and face before eating, drinking, and smoking. Remove contaminated clothing and protective equipment before entering eating areas. Do not get in eyes or on skin or clothing.

Do not breathe vapor or mist. Do not ingest. Use only with adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Keep in the original container or an approved alternative made from a compatible material, kept tightly closed when not in use. Empty containers retain product residue and may be hazardous.

## SECTION 10: STABILITY AND REACTIVITY

**Chemical Stability:** Stable at room temperature. No specific test data related to reactivity is available for this product or its ingredients.

**Hazardous Reactions:** Reaction with water (moisture) produces CO<sub>2</sub> gas. An exothermic reaction with materials containing active hydrogen groups can occur. The reaction becomes progressively more vigorous and can be violent at higher temperatures if the miscibility of the reaction partners is good or is supported by stirring or by the presence of solvents. This material is insoluble with, and heavier than, water and sinks to the bottom, but reacts slowly at the interface. A solid water-insoluble layer of polyurea is formed at the interface by liberating carbon dioxide.

The material will react with water, alcohols, amines, bases, and acids.

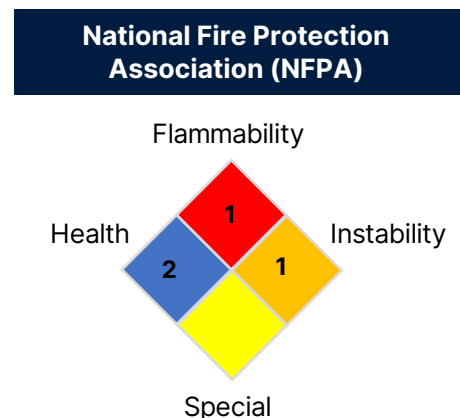
